- This is the only office on the 18th floor. Someone will be there to greet folks on the day of the meetings.
- From the Delta Halifax Hotel, Barrington Tower can be reached from a ped-way and underground walkways. There is no need to go outside, just follow the signs for Barrington Tower. The elevators are through glass doors next to Starbucks.
- The city bus from the airport arrives at Albemarle Street (behind the hotel, accessed through a stairway). The shuttle bus and cabs from the airport will drop you off in front of the hotel.
- For those living/ arriving in town, parking is not ideal. There is \$16/day parking in scotia square. Metered parking on the street, or \$8/day at Centennial Pool (3 blocks away). The office is only two blocks up from the ferry, or the bus stop is meters from the front door.



Local Transportation Options from Airport to Delta Halifax Hotel

1. Halifax Metro transit (city bus) has a bus that runs on a fixed schedule to and from the airport. It drops people off on the street behind the Delta Halifax. The cost is \$3.50 and it takes about one hour.

 There is a shuttle bus operating to and from the airport. It runs from the airport directly to Delta Halifax. It costs \$34 (half that one way). About 30min ride.
 Website for schedule and pre-pay http://www.maritimebus.com/en/ 3. Taxi service. There is no additional fee to share a cab. Taxis are \$63 one way. Taxis leaving from the airport do not need to be booked ahead. There is a taxi stand outside the arrival doors at the airport. It might be best for working group members heading to the airport on Thursday afternoon to share a cab as it will be quicker than the bus.
